

**ORDINANCE # 522**

**AN ORDINANCE PROVIDING THAT FUND # 310 RECREATIONAL AREA IMPROVEMENTS WILL TRANSFER TO #001 GENERAL FUND THE AMOUNT OF \$173.00 AND FUND #310 RECREATIONAL IMPROVEMENTS AREA WILL BE CLOSED.**

WHEREAS: The Town Council of the Town of Yacolt, Washington has notice of time and place, and in its regular session this 17<sup>th</sup> day of November 2014; and

WHEREAS: The Recreational Area Improvements Fund was created for the purchase of property and improvements; and

WHEREAS: The Recreational Area project has been completed and any additional improvements will be funded through the General Fund using BARS accounting under Parks; and

WHEREAS: The Recreational Improvements Fund was not used in the budget year 2014; and

WHEREAS: The amount of \$ 173.00 is necessary to transfer to the General Fund # 001 in so that the Recreational Area Improvements Fund # 310 can be closed; and

**NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Yacolt, Washington, as follows:**

**Section 1 Transfer:** Fund #310 will transfer the entire balance of \$173.00 to Fund # 001 General Fund

**Section 2 Closure:** Fund # 310 will be fully closed and no longer part of the budgetary process.

**Section 3 Severability:** If any section, subsection, paragraph, sentence, clause, or phrase of the is Ordinance is declared unconstitutional or invalid for any reason by a court of competent jurisdiction, or its application to any person or circumstances is held invalid, the remaining portion of this Ordinance shall remain in full force and effect, and the application of the provision to other persons or circumstances shall not be affected.

**Section 4 Effective Date:** This ordinance or summary thereof consisting of the title shall be published in the official newspaper of the town and shall be in full force five days after publication.




