

**ORDINANCE # 518**

***AN ORDINANCE AMENDING ORDINANCE # 406 STORM WATER SERVICE FEE, SECTIONS 1 & 2 OF THE TOWN OF YACOLT, WASHINGTON INCREASING FEES TO \$6.00 PER RESIDENTIAL HOME AND \$6.00 PER 3000 SQ.FT OF COMMERCIAL AND INSTITUTIONAL IMPERVIOUS SURFACE AND REPEALING OF ORDINANCE # 469.***

Whereas: The Town Council of the town of Yacolt in its regular session on this 2nd day of June, 2014;

Whereas: All members of the Town Council have had notice of time and place and purpose of said meeting;

**NOW THEREFORE, be it Ordained; by the Town Council of the Town of Yacolt, Washington:**

*AN ORDINANCE AMENDING ORDINANCE # 406 STORM WATER SERVICE FEE, SECTIONS 1 & 2 OF THE TOWN OF YACOLT, WASHINGTON INCREASING FEES TO \$6.00 PER RESIDENTIAL HOME AND \$6.00 PER 3000 SQ.FT OF COMMERCIAL AND INSTITUTIONAL IMPERVIOUS SURFACE AND REPEALING OF ORDINANCE # 469.*

**Purpose: Amend Sections 1 and 2 of Ordinance # 406** of the Town of Yacolt, adopted 4<sup>th</sup> day of December 2000. Repeal Ordinance # 469 entirely.

**Ordinance # 406 is hereby amended as follows:**

**Section 1: Residential and Institutional Surfaces**

The Town of Yacolt shall impose storm water service fee pursuant to RCW 90.03.500, based on residential home or institutional impervious surface square footage with in the town limits of the Town of Yacolt. A storm water service fee will be included as a separate charge on monthly bill of water consumption.

**Section 2: Storm water Service Fees**

A storm water service fee of \$ 6.00 per residential home or storm water service fee of \$6.00 per 3000 sq. ft. of commercial or institutional impervious surface will be charged monthly to each resident or property owner within the Town of Yacolt.

**Repeal of Ordinance #469.**

Ordinance #469 of the Town of Yacolt, adopted 6<sup>th</sup> day of December 2010, entitled "AN

ORDINANCE AMENDING SECTION 2, OF STORMWATER ORDINANCE #406 OF THE TOWN OF YACOLT, WASHINGTON, INCREASING STORMWATER FEES BY \$1.00" is hereby repealed in its entirety.

**Savings Clause**

All other terms of Ordinance #406, as amended, shall remain in full force and effect until the effective date of this Ordinance #518.

**Severability-**

If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance # 518 is declared unconstitutional or invalid for any reason by a court of competent jurisdiction, or its application to any person or circumstances is held invalid, the remaining portion of this Ordinance shall remain in full force and effect, and the application of the provision to other Persons or circumstances shall not be affected.

**Effective Date**

Ordinance # 518 shall take effect immediately upon adoption and publication of the following summary, according to law.
