B. C-Tran Board Composition Review-Lewis Gerhardt

Council member Gerhardt attended a C-Tran Composition Review Committee on June 11, 2013. The Committee meets every 4 years to discuss composition of the 9-member Board of Directors. Clark County Council Member David Madore proposed changes in the Board's composition to reduce the number of Board members for Clark County and the City of Vancouver to 2 each. Vancouver would like to increase its number of Board members to 4. Under the Madore proposal, Battle Ground would have its own seat on the Board, and Yacolt would share a Board seat with the City of LaCenter. The City of Vancouver opposes this plan because it would lose influence and control over the Board, including its block veto power. The Composition Review Committee tabled further discussion of the issues until its next meeting scheduled for July 9, 2013
