F. Citizen Compliant/ Recommendation – Council-member Myers

Vince Myers, Council-member had received a complaint from a resident about the ATV's and Dirt Bikes destroying property at the Recreation Park. The mounds of dirt were being destroyed along with the parking lot area. Council-member Listek brought up the wood piles that had nails in them that kids were playing on also. There was discussion on these issues and possible remedies. Concerns were that the town would be held liable if there was an injury. The Clerk will look into posting signs and getting some kind of barrier net to detour the damage. The discussion included reminding citizens to call 911 even in as non-emergency to document the activity.
