Dear Mayor Carothers:

At the North Country EMS Administrative Board meeting on January 26, 2017 it was approved to authorize submission to the voters a special excess levy for North Country EMS.

Approximately one third of North Country EMS' operating revenue is dependent upon an excess levy. This is not a new levy, but a continuation of the 2014 levy which had an overall voter approval rating of 81% across the three districts which make up North Country EMS.

Accordingly, I am enclosing a copy of two resolutions for the Town of Yacolt Council to act on in their capacity as Town of Yacolt EMS. The first resolution is for approval to place the measure on the August 1, 2017 ballot and the second is to run again on the November 7, 2017 ballot should the measure fail in August. Since the excess levy has been placed on the ballot there has never been a levy failure. However, because the deadline for the November ballot is the same day as the August election we will need approval to run in November should it not pass initially.

The resolution attached is explanatory of the amount requested and the purpose of the levy. It is an updated copy of the one we submitted in 2014. If you would like any additional information, please let me know.

I would appreciate a copy of the signed final resolution and any information on what further steps we need to take.

WHEREAS, the Town Council of the Town of Yacolt, Clark County, Washington, is proposing submission to the voters of the District at an election to be held therein on August 1, 2017, a proposition authorizing a levy to be made in 2017 for collection in 2018 upon all taxable property within the District of \$133,786, the estimated cost to be approximately \$1.40 per \$1,000 assessed valuation in excess of the maximum tax levy specified by law for Emergency Medical Service Districts without a vote of the electors for the General Fund of the District.
